# Attachment

## Judges

Each team must provide one judge for every 5 formations:

- 1 judge: up to 5 formations
- 2 judges: up to 10 formations
- 3 judges: up to 15 formations
- ...

The judges must be named in the final registration, including their licence level and email address.

If a team cannot provide enough judges, they can be recruited from other teams.

If the required number of judges cannot be provided/recruited, a penalty of €50 per day will be payable.

The judges must be available for the entire competition, regardless of the qualification for the final!

On all days, the judge conference will take place 45 minutes before the start of the competition.

## Name of Music and Tariff Sheets

1. Serial number according to the start list
2. Discipline (w2/m2/mx/w3/m4)
3. Routine (BA/DY/CO)
4. Category (KFL1 / KFL2 / WKK1.1 / WKK1.2 / WKK2 /asp/pre/you/jun/sen)
5. Club in short form, always four letters (e.g. TKVO = TKV Oberforstbach, KSVK = KSV Kirchlinde, ...)
6. Names of participants
